





STEPS TO ACCESS YOUR PITTPERKS

To access PittPerks, employees must do the following:

- 1. Log into My.pitt.edu
- 2. Select **My Resources**, then Human Resources in the top menu bar.
- 3. Select **PittPerks Access** on the ride side menu to be taken to the PittPerks homepage.
- 4. To access Legal Services enrollment, click the **Open Enrollment** banner at the top of the homepage.
- 5. On the **Pick Products** page, click the button next to the rate to select the legal product and then click "Enroll & Continue." (You may waive coverage for this product by clicking "No Thanks")
- 6. On the **Your Info** page, complete the required fields and then click "Continue." (Note: Email is editable and can be a work or personal email)
- 7. On the Confirm Details and Check Out page, click all boxes acknowledging you are in agreement with the terms and then click "Enroll" to complete your election. You will see an enrollment confirmation screen and receive an email to the email address you enrolled with, summarizing your election.
