### By phone:

TIAA-CREF financial consultants are available to answer your questions at the University of Pittsburgh Retirement Plan Call Center at **800 682-9139**, Monday to Friday, 8 a.m. to 10 p.m. (ET), and Saturday, 9 a.m. to 6 p.m. (ET).

### Online:

You can manage your account online on a 24/7 basis. Just go to [www.tiaa-cref.org/pitt](http://www.tiaa-cref.org/pitt) and log on to the secure section of the site. First-time users will need to click on *Register for Access* and set up a User ID and Password.

### In person:

Schedule a one-on-one counseling session with a TIAA-CREF financial consultant on campus or at the local TIAA-CREF office in Pittsburgh at [www.tiaa-cref.org/schedulenow-PITT](http://www.tiaa-cref.org/schedulenow-PITT) or by calling **800 782-8353**, Monday through Friday, 8 a.m. to 8 p.m. (ET).

The University of Pittsburgh just updated the Retirement Savings Plan site to include both TIAA-CREF and Vanguard funds. TIAA-CREF, as the sole recordkeeper, is ready to help you set a course with all of your retirement savings related needs.

Get started by reviewing the checklist below:

#### ☐ Review your beneficiary designation.

To review or change your current designation(s), log on to [my.pitt.edu](http://my.pitt.edu), select *My Resources* and then *Human Resources*. Then click *Retirement Plan Access*. Under *Manage My Portfolio*, click on *Beneficiaries*. Please note that these three instances require you to resubmit your beneficiary election(s):

- Your previous designation was a Trust.
- You are married and your previous designation was not your spouse.
- You held Retirement Savings Plan accounts at both TIAA-CREF and Vanguard.

If you do not resubmit your beneficiary designation, 100% of your assets will be set to the plan default, which is your spouse (if you are married) OR your estate (if you are not married and any of the three scenarios above apply).

Please contact TIAA-CREF to get help to review and/or change your beneficiary designations. If you are no longer employed by the University, you may visit [tiaa-cref.org](http://tiaa-cref.org) to ensure your designation accurately reflects your preference. After logging in, click on the *Manage My Portfolio* tab and select *Beneficiaries*.

#### ☐ Get help: face to face, by phone or online.

You're eligible to receive personalized advice on the University of Pittsburgh Retirement Savings Plan investment options from a trained TIAA-CREF financial consultant. Your consultant will help you find answers to the following questions (and more):

- How much do you need to save to reach your goals?
- Does your investment mix reflect your goals and risk tolerance?
- How will you meet your retirement income needs?

This service is available as part of your Retirement Savings Plan *at no additional cost to you*. TIAA-CREF's investment advice takes the form of specific asset allocation recommendations on mutual funds and annuities, which is provided by Ibbotson Associates, Inc., an independent third-party asset allocation provider.

#### ☐ Review your investment options.

To view the investment options, which now include both TIAA-CREF and Vanguard on the consolidated recordkeeping platform, visit [www.tiaa-cref.org/pitt](http://www.tiaa-cref.org/pitt) and select *Plans and Investments*. Many options are now available at lower pricing. If the funds that you're invested in qualify for the lower cost, they have automatically been moved to the lower-cost option of that fund.
